1. Purpose

As part of ongoing efforts to support learner mental health and wellness, and to recognize the impact of the pandemic, Athabasca University is giving learners the option to opt for a flexible grading option for any **one course** per academic year (September through August).

2. Scope

The Policy is applicable to both undergraduate and graduate learners attending the University. The Policy is temporary and will be in force for courses completed between March 1, 2020 and December 31, 2022. This Policy will be reviewed in December 2022 to determine if it needs to continue, based on the current pandemic situation.

NOTE: The flexible grading option may not apply for courses with external accreditation requirements. In such cases, these courses and programs will be ineligible. Learners should consult with Academic Advising for guidance.

3. Definitions

Grade Point Average (GPA)	The cumulative grade point average of all Athabasca University completed courses.
Grade Point	A grade point is a number between 0 and 4.00 that is assigned to a grade (alpha or percentage) and then used to calculate a grade point average (GPA). The grade point value is reflected on the Official Student Record.
Official Student Record	An official document issued by AU that confirms courses completed and the grades achieved in those courses. Also called the transcript.

4. Guiding Principles

- a. Learners in undergraduate and graduate programs may want to select <u>one</u> course per academic year for the flexible grading option.
- b. Course eligibility will be based on the grade achieved as follows:
 - Undergraduate learners must have passed the course with a grade of C- or higher.
 - ii. Graduate learner must have passed the course with a grade of B- or higher.
- c. Official final grades must have been posted for the select course before any request for Compassionate Grading is considered. The request must be made within 30 days of the end of this Policy.
- d. The grade will become unweighted and will not be included in their GPA calculation. It will appear on the learner's Official Student Record (transcript) as a "P" for Pass.
