### Purpose

To set the fees that Athabasca University may require to be paid under section 93 of the Freedom of Information and Protection of Privacy (FOIP) Act for services provided in responding to formal requests for access to information (formal FOIP requests).

### Definitions

<b>Applicant</b>	A person who makes a Formal Access Request to the University.
<b>Formal Access Request</b>	A written request to the University under section 7(1) of the FOIP Act to access a record in the custody or under the control of Athabasca University containing general or personal information.
<b>Head</b>	The person designated under section 95(a) of the FOIP Act as the Head of Athabasca University for the purposes of the FOIP Act.
<b>Informal Request for</b>	A request that is not a Formal Access Request for a copy of an

individual's personal information or for general records and that is subject to Athabasca University's regular reproduction and service fees.

## **Personal Information**

Means recorded information about an identifiable individual as specified in section 1(n) of the FOIP Act.

## **Policy Statements**

1. Pursuant to section 95(b) of the Freedom of Information and Protection of Privacy (FOIP) Act, R.S.A. 2000, c. F-25 and a Motion of the Athabasca University Governing Council Executive Committee respecting Motion Number 160-7 at Meeting Number 160, held on November 27, 1998, Athabasca University Governing Council Executive Committee adopts the fee schedule provided by section 93 of the FOIP Act and the FOIP Regulation (A.R. 200/1995, as amended from time to time) for Formal Access Requests. The provisions of section 93 of the FOIP Act and sections 9-13 of the FOIP Regulation are specified in the Policy Statements that follow and in the related Procedures.
2. The Head of Athabasca University may require an applicant to pay to Athabasca University fees for services respecting Formal Access Requests, as provided for in the FOIP Regulation, but not for a request for the Applicant's own personal information, except for the cost of producing the copy.
3. If an applicant is required to pay fees for services under subsection (2), the University must give the Applicant an estimate of the total fee before providing the services.
4. The Head may excuse an Applicant from paying all or part of a fee if, in the opinion of the Head:
  - (1) the Applicant cannot afford the payment or for any other reason it is fair to excuse the payment, or
  - (2) the record relates to a matter of public interest, including the environment or public health or safety.
5. The fees referred to in subsection (2) must not exceed the actual costs of the services provided.
