Purpose

These procedures are intended to provide consistent criteria which are to be used by all graduate programs in special circumstances when the temporary restriction of publication of theses and dissertations is deemed necessary, as per the Temporary Publication Restriction of Theses and Dissertations Policy.

Definitions

Publication Making information publicly available in a reproducible form in AUspace and

Library and Archives Canada.

Procedure

1. It is the responsibility of the supervisor to inform the student of policies or regulations that will affect the publication of their thesis or dissertation, such as requirements of agencies from whom the student may receive funding for their research and the University's policies such as public access to research results (Publication of Research) and the Temporary Publication Restriction of Theses and Dissertations policy, in their early discussions with the student regarding their research topic.

It is the responsibility of the supervisor to advise students prior to approving their research topic, against selection of a thesis or dissertation topic if the results cannot be published immediately upon fulfillment of the requirements of their degree.

Anonymity and confidentiality of participants and data in research is paramount. Approval from the AU Research Ethics Board will ensure that the anonymity of the sample (whether individuals, groups or organizations) is maintained. The Freedom of Information and Protection of Privacy Act and the Freedom of Information and Protection of Privacy Regulation also dictate that personal information not be included in documents that are considered to be public.

- 2. A request to withhold the publication of a thesis or dissertation must be made to the Dean, Faculty of Graduate Studies in accordance with the criteria specified in the Temporary Publication Restriction of Theses and Dissertations policy.
- 3. The student and supervisor must submit this request no later than when arrangements for the final oral examination are being discussed (at least 2 months prior to the anticipated date of the final oral examination).
- 4. The form Request for Approval to Temporarily Restrict Publication of a Thesis or Dissertation is to be completed by the student and supervisor (form attached).
 - a. The student initiates completion of the form.
 - b. The student specifies the restriction period up to a maximum of 12 months.
 - c. Documentation must accompany the form indicating how the request corresponds with one of the policy's criteria to restrict the publication of the thesis or dissertation.
 - d. The supervisor must sign the form indicating they agree with the request and may provide additional supporting arguments for the request and/or the length of the time restriction.
- If external funding is involved, it is the responsibility of the student to consult with their funding sources regarding time restrictions on publication of research results. The length of time requested may be influenced by publication restrictions of various agencies who funded the student's research.
- 6. The student may choose to restrict access to their thesis or dissertation if posting their thesis or dissertation will interfere with traditional publication. While many journal and book publishers accept a thesis for traditional publication even if it is already available electronically on the website of an educational institutional, such as AUspace, there are some publishers that do not. It is the student's responsibility to become acquainted with the policies of a prospective publisher. If the publisher specifies a restriction period this should be provided under the "other" category for reasons for temporary restriction.
- 7. The request is submitted to the graduate program designate in the student's academic unit, who indicates their agreement with the request with recommendation to the Dean, Faculty of Graduate Studies.
- 8. The Dean, Faculty of Graduate Studies determines the outcome of the request.

- 9. The AU Library will post the abstract of the thesis or dissertation in AUspace with the disclaimer that the document has 'restricted access for the period of _____ months until dd/mm/yyyy)'. The thesis or dissertation will not be made available for student or public access or for harvesting by Library and Archives Canada until after the restricted period.
- 10. Upon expiration of the restriction period, the thesis or dissertation will automatically be made available for publication in AUspace and harvesting by Library and Archives Canada.
